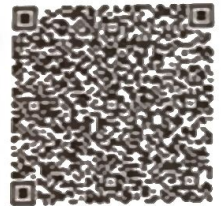

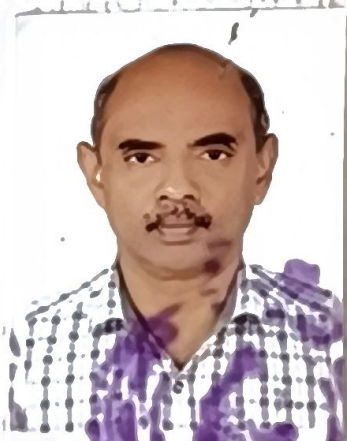
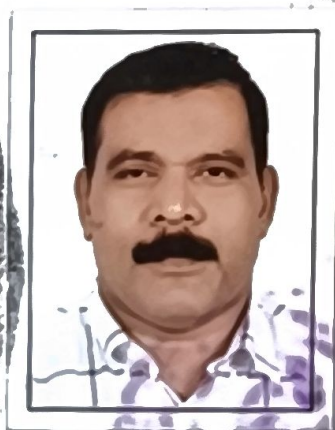

Whereas the parties the referred to above had made a declaration of trust on 14th day of October 1998 in the name and style **IQRAH EDUCATIONAL TRUST** registered as document number 108 /1998 of the of the subregistry office Codacal and the trust deed number 108/1998 of the sub registry was amended bearing as document number 96/2005 of the sub registry office codacal and again in 2015 amended bearing as document number 162/2015 of the sub registry codacal and again in amended as document number, registered as number 93/ 2018, Book 4, Volume 243, parted 7 to 13 pages.

Whereas for good reason and consideration and in order to perpetuate the smooth functions of the Trust, for achieving the object of the trust the above parties indented to amend the Trust deed.

And whereas the Trust has already undertaken the setting up and running of scholl at Cheriyyaparappur and has undertaken other philanthropic activities

And whereas the above parties who had floated the above trust had now verified and scrutinised the original deed of trust referred to above and had also sought legal opinion and had noted that certain mistakes had crept in while preparing the above Deed of trust and that

certain legal requirements have been omitted to be incorporated in the said Deed of Trust and also that some of the matters provided for is quite vague while some of the provisions do not set out the intention of the deed of trust.

AND WHEREAS clause XIII of the above Trust deed empowers the Board of Trustees to admit new members and the Board of Trustees by its Resolution No. 3/2024 Dated 03.06.2024 in the meeting of the Board of Trustees held on 27/07/2024 have decided to admit the new Trustees to execute a Deed of Trust including the new Trustees

AND WHEREAS it is found necessary to carry out several amendments and changes to the various clause laid down in the above referred deed of Trust in order to bring forth the true intention and conditions for which and under which the trust was formed;

NOW THEREOF in view of the several amendments that are required to be carried out, the following **AMENDED TRUST DEED** is being executed in place of and in supersession of above mentioned registered trust deeds in order to achieve the objects of the trust which shall relate back to 14.10.1998. On which the original trust deed was executed by the founder. Whereas the board of trustees had passed resolution unanimously comments the trust meeting on 26/07/2024. The trust board also approved the amendment of trust deed and decided to register the trust deed before the sub register office Codacal. Now the deed witnessed and do hereby declare as follows

1. General

1. Name: The name of the trust shall be **IQRAH EDUCATIONAL TRUST**
2. Address: The address of the trust Shall be **IQRAH EDUCATIONAL TRUST**

3. Office: The office of the trust shall be at Room number 108, ward No.VIII of Triprangode Panchayath. However, it's Shall be open to the trust to shift the office to any other place of convenience.

II. Area of operation

The area of operation shall be the entire state of Kerala. However, the board of Trustees shall have the right to enlarge the area of operation. The area of operation specified Supra and such wider area as maybe decided by the board from time to time.

III.AIMS AND OBJECTIVES OF THE TRUST

1. To establish and manage educational institution for uplift of the Muslim Minority Community.
2. Carry out charitable works for the betterment of all communities and religion without reference to caste, creed or religion and for the said purpose, to set up educational institutions, academics, research Institution and the like ;
3. To evaluate the abilities of students in the field of academic studies, cultural events etc. and to take the effective steps for imparting proper coaching in such fields.
4. To set up Institutions and establishments for imparting literacy to general mass and eradicates illiteracy among the member of down trodden.
5. To acquire properties of achieving the above aims and objectives and maintain and the project such properties.
6. To work for the improvement of members of all classes in the cultural and social and educational fields by conducting seminars, classes etc. On subject of national importance.
7. To set up and run educational institutions like Schools, Colleges and Professional Colleges and Institutions involving Medical, Engineering, Para Medical, Information Technology, Management studies etc. and to set up training centers, Pharmac and Nursing Colleges for the uplift of the socially backward classes, especially the Muslim Minority Community.

IV. POWERS AND DUTIES

1. The trust shall be the authority to set up institutions, Academies, Colleges, schools etc. though the running of such individual establishments shall be carried out through Managing Committees set up for each of such institutions, such institution shall be set up by using the corpus of the Trust and by collecting donations from the public and other Charitable Institutions, Trust, etc having identical objects and to run the same.

2. To supervise and control the running of such institutions in order to ensure that such Institutions run in accordance with the aims and objects of the Trust.

3. Lay down the ground rules of running of such institutions.

4. Take policy decisions on the setting up of and running of various Institutions, Academics, Colleges, schools etc and obtain recognition from the minority commission for the minority status.

5. To do such act / acts as may be found necessary for achieving the objects of the Trust within the frame work of this Deed of Trust.

V. OFFICE BEARERS: RIGHTS AND DUTIES

1. Chairman

- i). The Chairman shall preside over the meeting of the Board of Trustees and control such meetings.
- ii). The chairman shall be appointing authority for all appointments made by the trust and shall be incharge of the accounts and shall be the authority to acknowledge receipts of all amounts by the trust either by way of donation or by way of addition to the corpus of the trust and be in charge of all institutions run by the trust. He shall also be the disciplinary authority in respect of all employees.
- iii). The chairman shall operate all bank accounts of the trust along with Treasurer and / or General Secretary.
- iv). The chairman shall be the custodian of all assets of the trust including all records, title deed etc.
- v). The chairman Shall operate bank accounts as authorised by the board of trustees in accordance with the resolutions adopted from the time to time.

2. Managing Trustee

- i) The Managing Trustee shall call for the meeting of Board of Trustees with the concurrence of the Chairman and Managing Trustee and shall for all the said purpose, issue notice and fix the agenda of the meetings.
- ii). The Managing Trustee shall have the right to nominate, as the representatives of the Board of Trustees, members to the Managing Committee/s of the various institutions set up by the Trust, from amongst the members of the Board of Trustees and to nominate specific members, out of such nominated members as Directors of the said Managing Committee/s.
- iii). The Managing Trustee here by nominees the members of the Board of Trustees as constituted now, to the Managing Committee of IQRAH ENGLISH MEDIUM SCHOOL run by the Trust which shall function according to the Rules and Bye-laws that may be framed by the said Managing Committee.

3. General Secretary

i) The General Secretary shall be responsible for the running of the various of the various projects of the Trust and responsible for the day to day running of the Trust and its Projects.

ii) The running of the various individual Institutions of the Trust shall be in coordination with the various managing committees floated for each such project.

4. Treasurer

i) The Treasurer shall be the custodian of all accounts and shall be responsible for effecting payments against the authorisation granted by the Chairman in accordance with the resolutions adopted by the board of trustees from time to time.

ii). The Treasurer shall ensure proper maintainance of the accounts of the trust and shall get the accounts audited in time every year and shall and ensure preparation of all statements to be filed before statutory and/or quasi governmental authorities from time to time. He shall also operate the bank accounts in accordances with the resolutions adopted by the board of trustees from time to time.

iii). Unless otherwise decided by the board of trustees, the treasurer shall ensure that all payments in excess of RS. 5000/- shall be incurred only through account payee cheques and all individual payments less than RS. 5000/- maybe incurred in cash, at the discretion of the chairman.

VI. MEETING OF THE BOARD OF TRUSTEES.

1. In the absence of the Managing Trustee at any meeting, Managing Trustee will appoint any of the trust members to convene the meeting. The quorum of the meeting of the board of trustees shall be 1/3 of total strength. In case any meeting of the trustees is adjourned for want of quorum the next meeting hall be convened within 15 days of such adjournment and the said meeting shall be proceded with irrespective of quorum.

2. Decisions of the Board of Trustees shall, as far as possible be unanimous. However, in the event of a vote being found necessary, such decisions shall carry the support of 2/3 of the total numbers present and voting at such meeting/s.

3. It shall be open to the Board of Trustees to approve of resolutions by circulation with the permission of the Chairman.

VI. OTHER MATTERS

1. All amounts received by the Trust as part of the Corpus and / or donations shall be used in accordance with the object of the Trust.

2. Trust fund

Fund for the sanction of the trust can be collected from the public and can be utilized in accordance with the objectives of the trust as per the decisions of the trust committee. Fund will be utilized to wards the objectives of trust and no portion shall be utilized for the payments to the trustees / members / office beares by way of profit/ dividend/ interest etc. All expenses incurred by the trustees for discharge and duties as trustees shall be met from the trust fund.

3. Investment of fund

The fund of Trust shall be invested strictly in accordance with the provisions of sub-section 5 of section II read with 13(1) (d) of the Income Tax Act 1961.

4. Auditing

The account of the trust may be audited by a chartered accountant or authorised qualified auditor.

5. The entire income of the Trust shall be used in accordance with the objects and aims of the Trust and in accordance with the terms of the Income Tax Act in existence.

6. The board of Trustees shall be entitled to formulate such rules and bye-laws and procedures as are found necessary for the proper running of the Trust and it's institutions.

7. All fixed assets including properties now available and those to be acquired in future shall belong to the Trust alone and shall stand in the official names of the Chairman and /or the Managing Trustee.

8. The Managing Trustee and the treasurer shall prepare every year, a budget for the operations of the Trust for 1 year and place the same before the Board of Trustees who shall accord approval for the same, subject to any changes that the Board may deem fit to carry out the activities of the Trust shall be run in accordance with the Budget and any changes in the same shall be carried out only with the approval of the Board of Trustees.

VIII. TRUST IRREVOCABLE

The Trust IQRAH EDUCATIONAL TRUST shall be an IRREVOCABLE Trust. In the event of cessation of the trust the net assets if any remaining after satisfying the debts and liabilities shall either be transferred to societies or trust having similar objects or shall be vested with the government.

REGULATIONS

By a majority of 2/3 of the trustees the board shall have power to frame regulations, helpful and ameliorative to the conduct and running of the trust but the regulations so framed shall be in no case be in no derogative or circumventing the direction of this deed.

IX. CORPUS OF THE TRUST AND APPLICATION OF NET INCOME OF THE TRUST.

1. The Corpus of the fund shall be RS. 5000/- which has been contributed by the Founder Trustees as evidenced by the Deed of Trust dated 14-10-1998. Any additions to the Corpus received from well wishers and donors shall be used by the Trust in accordance with the object and aims.

2. This Amendment Deed Shall be deemed to have come into existence on 14-10-1998, the date on which the original Deed of Trust bearing No.108/1998 was executed and registered.

3. The net income of the Trust shall be utilized in accordance with the objects and aims of this Trust as stipulated above and shall be applied, in accordance with the provisions of Indian Income Tax Act and no part of the same shall be used for the personal benefits of either the Founder Trustees or the members of the Board of Trustees.

X. AMENDMENTS TO THE TRUST DEED

The rules and regulations of the trust may be amended or altered after obtaining approval as maybe necessary from the commission of Income Tax and such other appropriate authority under the law for the time being inforce by 2/3 of the members present and any amendment or alteration for made shall be with written of the commission of the Income Tax having jurisdiction of the association.

Whereas, executant no.1, herein, the founder trustee relinquished all his rights, claims, fund whatsoever to the newly constituted trustees and office bearers by virtue of this Trust deed; hereafter trust can amend or take any decision as per the decision of Trust board in the absence of founder trustee and it is legally binding before any authority.

DISSOLUTION

The Trust maybe dissolved at a general body meeting convened for the purpose by a majority of atleast 2/3 of the members in person and approved by the settlers and there upon its affairs shall be adjusted with another trust or society with similar or nearly similar aims and objectives of the trust or in the absence to the government.

This document shall be deemed to be part and parcel of Doc No. 108/1998 executed on 14-10-1998 and subsequently and enclosed as per the Document No. 96/2005 registered on 09.05.2005 and again amended in 2015 as per Document No. 162/2015 of sub Registry Codacal as carrying out amendments and corrections to the terms and conditions stipulated therein as admitted by the Founder Rustee Poolakkal Mujeeb, Chairman Pachakunnath Muhamed Musthafa and the General Secretary Pachakunnath Jameel Sha in the presence of the under mentioned witness :
